12 1. NOW COMES, **Moshe Yoseph Koniuchowsky**, who makes the following statements by
13 affirmation with personal knowledge of the facts by this declaration.

14 2. Said Declaration shall be used as needed and on a need to know basis. Said Declaration is
15 intended to provide full disclosure, when necessary and is not intended to conceal facts, to commit any
16 fraudulent act(s) or to avoid any debts. Said Declaration is generated upon advice of counsel Shawn
17 Talbot Rice Ovs of Phoenix, Arizona (623-825-1887).

18 3. **Moshe Yoseph Koniuchowsky** was born the 10 day of September, A.D. 1957. My birth
19 name is "**Maushe Joseph Koniuchowsky**." Said name is pronounced the same as Moshe, but because my
20 father wanted Moshe and my mother wanted Michael or Mitchell or something similar they compromised
21 on the spelling. Therefore, my parents left my birth name (as listed on my Birth Certificate) as "**Maushe**."
22 However, **Maushe** is pronounced the same as Moshe. Therefore, I use the initials "MJ" on licenses and
23 other legal matters so I do not have to explain why it is spelled **Maushe Joseph** instead of **Moshe**
24 **Yoseph**.

25 4. I have used the name of Marshall in previous work in the commercial arena after college. I
also used the same name Marshall as a Baptist Pastor and was known as "Pastor Marshall." I took that
name because Jewish believers in Yeshua HaMashiach (a.k.a. Jesus Christ) were looked down upon. I no
longer use the name Marshall.

1 5. I am generating this document due to the fact that people attack me and/or bring up false
2 charges that my name is really Marshall and not Moshe, and that I am somehow intentionally deceiving
3 people. I deny such an allegation.

4 6. In the near future I intend to settle this matter once and for all through a formal name change
5 court action in County Court held in Broward County. My name is and shall be legal acknowledged as
6 **Moshe Yoseph Koniuchowsky.**

7 7. The State of Florida, etc will issue identification cards to Moshe Yoseph Koniuchowsky with
8 my likeness.
